Fill out the LUMICEF Patient Assistance Program application form, and submit proof of income required for means test

Applicant should fulfill the following condition(s):

- Household disposable assets ≤ HK\$1,000,000 or
- Monthly total domestic income ≤ HK\$100,000

## Step 3

Patient attends medical appointment with letter of confirmation presented; doctor will examine the person's medical condition to assess suitability for biologic treatment. Once patient is diagnosed to be suitable to receive, enrolment to the program will be confirmed.

St. James' Settlement reserves the right to modify any of the terms and conditions aforementioned. In case of dispute, the decision of St. James' Settlement shall be final.
